Terms and Conditions

PLEASE READ THE FOLLOWING BOOKING CONDITIONS CAREFULLY. THESE OUTLINE OUR OBLIGATIONS TO YOU, AND YOUR RESPONSIBILITIES TO US.

These terms and conditions are the entire agreement between you and the organisers of the Global Crystal Bowl Symposium 3 (GCBS3) on 6 – 12 November 2024.

These terms and conditions are governed by Australian law and the parties submit to the non-exclusive jurisdiction of the courts of Australia in respect of any dispute or proceeding.

On the Registration Form, you will be asked if you have read these Terms and Conditions. If you tick YES and you have not fully read these Terms and Conditions, we take no responsibility for this.

CANCELLATION POLICY

Before purchasing a place at the GCBS3, please make note of the cancellation policy as set out below. It is your responsibility to read and understand our cancellation policy before making a booking.

So that you understand our process, as soon as you book, a percentage of your payment goes to accommodation, meals and other supplier costs.

IF YOU CANCEL -

- Before 1st July 2024, you will receive a refund of all monies paid for the Symposium package less a USD \$300 cancellation fee.
- Before 15th September 2024, you will receive a refund of all monies paid for the Symposium package less USD \$1,000 cancellation fee.
- After 15th September 2024, there is no refund.
- If you cannot attend, it is possible to transfer your place to another person and it will only incur a \$50 administration fee.
- On compassionate grounds, at our discretion, we may waive the cancellation fee.

IF WE CANCEL -

If we cancel GCBS3 you will receive a full refund of your symposium payment, within 90 - 180 days of being notified of the cancellation.

We will not be responsible for your airfare or any other purchases that you made to attend this event.

INSURANCE

Your safety and security is of utmost importance to us, therefore please purchase International travel insurance for the GCBS3. We require you to send a copy of your insurance certificate to carmen@calmandcreative.com.au before your departure for the symposium. We have this in case of emergency so we can liaise with the relevant body.

We recommend you take out insurance from the day you make your first GCBS3 payment as this can cover you for a number of events including illness and some cancellations (please read their disclaimer carefully). Please note that travel insurance does not cover you for simply changing your mind.

We are not responsible for your expenses incurred in preparation for the Symposium, such as airline tickets, loss of work, and/or other costs associated with preparing for your trip.

PASSPORT AND VISA

It is your responsibility to ensure you have a valid passport (including a minimum 6 month validity from the return date) and a visa if applicable. We recommend using the official government site to purchase your Cambodia visa. Make sure you leave adequate time to receive your visa before departure.

- 2) Waive any right to bring an action for loss or damage against the Symposium organisers, venue or others associated with GCBS3 where assistance/treatment (provided or attempted) has accidentally worsened your condition.

RELEASE OF LIABILITY

As a GCBS3 Participant you hereby agree to release, indemnify, and discharge the Symposium Organisers and Partners (and/or their directors, family, employees, co-facilitators, volunteers and

representatives) on behalf of yourself, your children, your parents, your heirs, executors, administrators, assignees, personal representatives and estate as follows -

- A. You agree that the Symposium Organisers and Partners are not responsible for any loss, damage, cost, expense, or other liability whatsoever incurred by arising out of
 - a) Injury, accident or death
 - b) Loss or delay of baggage or other property; and or
 - c) Any delay, inconvenience, loss or enjoyment, or frustration, whether physical or mental resulting from, but not limited to any of the following factors:
 - i. The act or omission of any party including the Symposium Organisers and Partners including volunteers.
 - ii. Mechanical breakdown, government actions, weather or any other factors beyond the Symposium Organisers and Partners control.
